

2026/27 Hyndland House – August Incentive Terms & Conditions

Property: PfP Students Hyndland House

Promotion Code: AUG300

Promotion Period: 1 August 2026 to 31 August 2026

1. Eligibility

1.1 This promotion is available to students booking accommodation at PfP Students Hyndland House for the 2026/27 academic year with a tenancy length of 40 weeks or more.

1.2 Eligibility is subject to the booking being fully completed, accepted by Hyndland House management, and all required tenancy documentation and payments being received.

1.3 The incentive is limited to one allocation per tenancy agreement.

1.4 The promotion applies only to new bookings made during the promotional period and where the promotional code AUG300 is quoted or entered at the time of booking.

2. Incentive Details

2.1 Eligible residents will receive £300 cashback.

2.2 Cashback will be processed following successful completion of the booking, tenancy commencement, and satisfaction of all tenancy requirements.

2.3 Eligible residents will also be automatically entered into a prize draw.

2.4 The prize draw will award 10 winners with free laundry for one academic year, subject to these Terms & Conditions.

2.4 Free laundry will be provided through the property's designated laundry credit system and is subject to the conditions set out in Section 3.

3. Credit Allocation and Use

3.1 Laundry credits will be allocated through the property's designated laundry system and in accordance with its operational procedures.

3.2 Credits may only be used for laundry services provided at Hyndland House and have no cash value.

3.3 Laundry credits are non-transferable, non-refundable, and cannot be exchanged for cash, credit, or any alternative benefit.

3.4 Any unused weekly credit will expire at the end of the applicable week and may not be carried forward unless otherwise determined by Hyndland House.

4. Tenancy Requirements

4.1 Residents must remain compliant with the terms and conditions of their tenancy agreement throughout the tenancy period.

4.2 If a tenancy is terminated, cancelled, surrendered, or otherwise ends before the agreed tenancy end date, any entitlement to future laundry credits will cease immediately.

4.3 Residents who cancel their booking before moving in, fail to take up occupation, or are released from their tenancy before the tenancy commencement date will not be eligible to receive the incentive.

4.4 Cashback and prize draw eligibility are conditional upon the resident successfully commencing and maintaining their tenancy in accordance with the tenancy agreement.

5. Availability

5.1 Hyndland House reserves the right to verify eligibility and determine the order in which bookings qualify for the promotion.

5.2 Hyndland House's records regarding qualifying bookings shall be final.

6. Prize Draw

6.1 All residents who qualify for the AUG300 promotion will be automatically entered into the prize draw.

6.2 Ten (10) winners will be selected at random after the promotion closes.

6.3 Winners will receive free laundry for one academic year through the property's laundry credit system.

7.1 Hyndland House reserves the right to amend, suspend, withdraw, or terminate this promotion at any time where reasonably necessary, including where circumstances arise beyond its reasonable control.

7.2 Any decision made by Hyndland House relating to eligibility, qualification, operation, or administration of the promotion shall be final.
